TERMS OF USE FOR SHAIRED PLATFORM OPERATED BY HULQ

Effective Date: November 14th, 2024

1. GENERAL TERMS

a. By accessing or using the SHAIRED platform (the "Service"), operated by HULQ, you agree to be

bound by these Terms of Use and our Privacy Statement. If you do not agree with these terms, you

must refrain from using the Service.

b. The platform was developed by and is owned and operated by HULQ. We reserve the right to

change these Terms of Use at any time without personal notice to you by updating it within the

Platform to incorporate the new terms of use. You are responsible for regularly reviewing information

posted online to obtain timely notice of such changes. Your continued use of the Platform after

changes are posted constitutes your acceptance of the amended Terms of Use.

c. You are responsible for all access to the platform through your electronic device and for bringing

these Terms of Use to the attention of all persons who may access the Platform.
